ORDER:-

The State Government have been contemplating to establish 3 Regional Sports Schools in the State so as to tap the talents of all budding Rural sportspersons and to project this State in the arena of sports at National/international level in a more effective manner.

2. To begin with, administrative sanction was accorded with an estimated cost of Rs.18.00 crores, towards construction of a Regional Sports School at Putlampally(v) Kadapa District in the GO 1st read above. It is reported by Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh that an amount of Rs.100.00 lakhs was also released to initiate the project and an extent of 100 acres of land was alienated in favour of District Sports Authority, Kadapa for this purpose.
3. In the reference 2nd read above, the Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh has reported that it may take considerable time to complete construction works and therefore, requested Government to permit him to commence the Regional Sports School temporarily, in the premises of Rajeev Institute of Medical Science, Putlampally(v), Kadapa District.
4. Government after careful examination of this proposal hereby permit Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh to commence the said Regional Sports School temporarily, in the premises of Rajeev Institute of Medical Sciences at Putlampally(v), Kadapa District, at a total cost of Rs.51.20 lakhs per year till the 1st phase construction works are completed on the proposed original site. The expenditure in this regard shall be met within the normal Budget provisions of Sports Authority of Andhra Pradesh. The teaching & non teaching staff required for this purpose shall be arranged on deputation or contract basis only, through manpower agency.
5. The Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh is requested to take necessary further action in the matter.
